

# With Art & Soul – Terms & Conditions

Welcome to With Art & Soul. These Terms and Conditions govern your use of this website, bookings, classes, services, events, workshops, and all offerings provided by With Art & Soul LLC (“we,” “us,” “Studio”). By accessing our website or booking any service, you agree to these Terms in full.

---

## 1. Acceptance of Terms

By accessing, booking, participating in, or paying for any With Art & Soul offering, you acknowledge that you have read, understand, and agree to be legally bound by these Terms and Conditions.

---

## 2. Booking & Payment

All bookings must be paid in full at the time of reservation. Prices, schedules, and service offerings are subject to change without notice. Memberships, packages, passes, and class credits are non-transferable and non-refundable unless expressly stated.

---

## 3. Cancellation, No-Show & Refund Policies

Service-specific cancellation, no-show, and refund rules apply, as described below. These policies are part of these Terms.

## 4. Yoga Sessions

Participation in yoga sessions is subject to the Studio's general Liability Waiver, which applies to all instructors, staff members, independent contractors, and guest teachers.

- Cancellations **<12 hours** before class: **50% charge** of reserved service.
  - **No-Shows: 100% charge.**
  - Bookings made within 24 hours must be cancelled **≥4 hours** before the session to avoid a 50% charge.

## 5. Massage & Bodywork

- Cancellations free up to **24 hours** before appointment.
  - Cancellations **<24 hours** before appointment: **100% charge.**
  - **No-Shows: 100% charge.**

## 6. Spa Services (Infrared Sauna, Salt Therapy)

Spa modalities require 24-hour advance cancellation. Cancellations after that time or no-shows will be charged **100%**.

## 7. Events, Workshops & Gatherings

Tickets are non-refundable once purchased.

Tickets may be transferred to another participant **only with written notice at least 24 hours prior to the event start time.**

The new participant must either:

- be registered with us in advance, **or**
- present the original ticket or confirmation at check-in.

Failure to notify us or provide proof of ticket transfer may result in denied entry without refund.

---

## 8. Unlimited Memberships (Recurring Passes)

Unlimited passes (including Yoga Unlimited and similar memberships) renew automatically on a monthly basis until cancelled by the client.

Cancellations must be completed at least 48 hours prior to the next billing date to avoid the upcoming charge. Once a renewal payment has been processed, that billing period is non-refundable.

After cancellation, access remains active until the end of the already-paid billing period.

Unlimited memberships are personal, non-transferable, and may not be shared.

All bookings made using an unlimited pass remain subject to the standard cancellation and no-show policies listed above.

With Art & Soul reserves the right to suspend or terminate memberships for repeated late cancellations, no-shows, or misuse of booking privileges, without refund.

## 9. Health & Participation

Participants are solely responsible for determining whether participation in any service, event, ceremony, workshop, or product use is appropriate for their physical, mental, and emotional condition.

All offerings provided by With Art & Soul are **not medical, psychological, or therapeutic services** and are **not a substitute for professional medical diagnosis, treatment, or care.**
